The Organiser reserves the right, at its sole discretion, to verify the data submitted and, if applicable, to request proof of the consent of a parent or guardian, as well as proof of your age, identity and/or other information.

6. ORGANISER'S RIGHT TO CHANGE TERMS AND DISQUALIFY

- 6.1 To the extent permitted by law, without affecting your statutory rights, the Organiser reserves the right to change, terminate, supplement or extend the promotion if it is of the opinion that the promotion is at risk from an event out of its control. The Organiser assumes no liability for losses or damages that you or third parties (whether direct or indirect) may incur. Data protection information in accordance with Art. 13 GDPR:
